Rules & Regulations

**Playing Conditions/ T20 rules:**

We will be following ACA T20 rules, most of which, can be found on the back pages of the cricket score-books and also using the following link, [Rules-Premier Men Twenty20](#)

Please make sure you read these rules before your first game to avoid any confusions moving forward.

**Over and Above these ACA rules and guidelines, Southern premier League has a set of rules as follows:**

1. As most of you are well aware, we do provide spare club gear for teams to use(except Balls) so,please ask for it or use your own and let's ensure we have a competitive, fun yet injury-free Sunday for the remainder of the season.
2. No spikes allowed for bowlers and batsman but fielder it would be fine.
3. **Team Captains:** Please Share details/identify playing 12 (including supersub) with/to Each Other, Umpires and Scorers before the Match. Its responsibility of the team , who is taking 12 players on board to inform other team captain , before the match kicks off. Super sub can come in the ground anytime , as long its informed.
4. **Square leg umpire:** We will be using a player from the batting team of the adjacent match to assist the Main Umpire as Square leg Umpire.

## **5. On Field Rules:**

- Umpire decision cannot be challenged on the ground.
- Any argument of physical abuse not accepted on the ground. Sledging is permitted.
- Max 2 outside the 30 yards first 6 over, thereon max 5 outside, at no point any more than 5 on legside
- Max 4 overs per bowler
- Any ball down the leg will be a wide
- One bouncer permitted per over.
- Free hit for every No ball
- Dangerous Beamers: 1st Beamer : Warning ; 2nd Beamer : Suspension from bowling in the rest of the match.
- No player may be changed after the nomination without the consent of the opposing captain and umpire.

## **6. Process for Protest/Grievance Redressal:**

On-field there will be competent, qualified and experienced Umpires and Scorers who are more than capable of making the right decisions. However, if your team still feels that there was something unfair that needs to be addressed then you will need to follow the following "Process for Protest"

- **Step 1)** Your captain needs to approach me directly and we can try to figure out a mutually agreeable solution on the field.
- **Step 2)** If a solution is not agreed on using Step 1, we will call for a committee meeting and find a solution **before 5 pm following Tuesday.**

## **7. Players**

- A player cannot play for more than one team during the competition.
- The Squad list of 15 players must be submitted prior to the start of the tournament to Indo
- No Player will be allowed to participate in the tournament if he is not listed on the submitted (Unless other side of the captain is agreeing)

## **8. Squad list.**

Only 3 Premier [or higher] grade cricket club players are permitted in a team's starting

## **9. Time for Per over & match**

Time allocated to bowl each over is 4 minutes for reduction of overs purposes. (e.g.

a 20 overs innings shall be completed in 80 minutes)

## **10. Points**

Win = 2 Points Draw = 1 Points

No Result = 1 Points Loss = 0 Points

## **11.Pools**

### **4 teams in Pool A & Pool B each.**

Each team will play 3 matches in their group. Team with more points will be on top of each Pool.

2 matches for Quarter Finals

## **12. For Semi- Final**

Top 2 teams of each Pool A & B will have matches to qualify for Semi finals. In case of any tie on points, run rate will be calculated.

## **13. The Grand Finals**

The team scoring the highest runs in the finals win. In case of a tie, a super over will be bowled for both teams.

**I can't reiterate enough, that these matches have been organized for you to have a good time, and get the best paying experience of your lifetime. Please keep in mind The Spirit Of Cricket as this is a Community Initiative, to ensure participation and involvement of more and more people moving forward. This is your tournament!**
